

Thanks for talking to me just now. As I mentioned, I work with Fontem Ventures, world leading producer of electronic nicotine delivery systems (ENDS), also known as e-cigarettes. Fontem Ventures is based in Amsterdam and produces leading brand *blu*.

Fontem is a champion of research in the field of vaping, working with public and private sector research bodies to expand understanding of the health impact of using e-cigarettes compared to traditional tobacco.
