



Joint Statement 29 November, 2021

Director General,
Excellencies,
Dear Friends all,

I deliver this statement on behalf of the 44 Member States from the Group of Friends of the Pandemic Treaty.

We recognize and celebrate the second special session of the World Health Assembly and the historic moment it represents. The COVID-19 pandemic has turned our world upside down and we have found ourselves struggling to stay resilient, strong, and together.

Unfortunately, infection rates are on the rise and inevitably, new variants will continue to challenge our weary health and scientific communities yet again. Our societies suffer and the most vulnerable populations are hit the hardest. Status quo will only strengthen our existing inequities and structural deficiencies.

Doing our best wasn't enough. Two years have passed by, and we are witnessing a push for more stringent measures, closures of businesses, schools and even borders. We are still battling this virus and dealing with the fall out of the mistakes that we made. Inequitable access to countermeasures, poorly distribution of vaccines worldwide and the slow reaction to a crisis that keeps disturbing our lives, needs to be addressed at the

This special session marks the historic moment in which we decide to embark on a journey to have a stronger agreement that will ensure implementation for prevention, preparedness, and response to the threat of outbreaks with pandemic potential. It is time to move forward and grasp this opportunity to transform our commitments into reality. Member States have had many discussions since this crisis started and today, we are pleased to adopt a decision based on consensus, to benefit the whole international community.

We have learned the hard way that no one is safe until everyone is safe. We will remember this pandemic as a wake-up call for global solidarity. And we will remember this World Health Assembly as the moment where we decided to commit ourselves and build a safer and healthier future for generations to come.

1. Short introduction of mr. [REDACTED], and his role in the INB Bureau
 - Thank you dr. [REDACTED]
 - Of course for my candidacy for the WHO EURO region on January 13th I gave a more extensive introduction, but for those who don't know me yet
 - My name is [REDACTED], and I am the Director of International Affairs at the Ministry of Health in the Netherlands.
 - During COVID I have also been the lead for the Netherlands on Covid-19 vaccine purchase and donation, experiencing first-hand the political, legal and administrative challenges in this process.
 - But in the broader context I have also been active in the Multilateral field for quite some time, especially with WHO, as FCTC board member, but before that as Health Attaché in Geneva.
 - Regarding the Pandemic Treaty, our Prime Minister Rutte was among the first to sign to Op-Ed that kick-started the process for a Pandemic Treaty or other legal instrument.
 - We therefore felt we should take responsibility for this next phase and help in coordinating the process.
2. A reflection on the last two INB Bureau meetings
 - We've had now two INB Bureau meetings, where we introduced ourselves, clarified some of the roles and expectations, and prepared for the first INB meeting on February 24th. Next week.
 - In these meetings we concluded that South Africa and the Netherlands would be presented as candidates for the co-chair positions in the first INB meetings
 - This is of course to be determined officially on the first meeting
 - Also, we discussed our own method of work as bureau, and discussed the materials that are on the agenda for INB1, with a proposed timeline, and importantly, the INB Method of work
 - These materials will be shared by the Secretariat, if they haven't been shared already
3. Looking towards INB1 starting on February 24th, and the way forward
 - Basically, in the first INB meeting next week, Member States can reflect on their expectations of the process, and their ideas on the method of work
 - We should ensure that the INB process is adequately aligned with the other processes of work at WHO, notably the working group on

pandemic preparedness and response, which is also next week, but also the Working group on sustainable financing, but also a few other activities, like the IHR amendments

- This requires a dance between the different groups, to ensure that intersessional meetings and public hearings will be connected, and the INB can extract the substantive elements and concoct the working draft no later than august 1st.

- 4. Call for reflections and considerations from WHO EURO MS on the process to draft and negotiate a convention, agreement or other international instrument
- As you all know, the road to a pandemic treaty is a road that should be taken together
- Similar to 'no one is safe, until everyone is safe', we need to ensure that a treaty will only work if we are all agreeing on it
- And for this process we need all the input we can get from Member States
- So at this point, I would like to ask for your reflections and considerations on the process to draft and negotiate a convention, agreement or other international instrument
- Of course, as the official process to collect and draft the substantive elements will take place in the INB, this WHO EURO meeting is not an official call for input, but in order to understand the sentiments with Member States, it is prudent for bureau members to listen.
- But in the Bureau, I will not be representing the EURO region;

Achtergrond:

Nederland ziet een centrale rol voor de WHO in de wereldgezondheidsarchitectuur, maar heeft ook geconcludeerd dat de wereld onvoldoende voorbereid was op een pandemie van deze omvang. Inmiddels is een groot aantal aanbevelingen verzameld om de wereldgezondheidsarchitectuur te versterken, en een belangrijk aantal daarvan passen niet in de IHR zonder deze helemaal open te breken. Een pandemieverdrag moet de IHR complementeren met inhoudelijke elementen zoals 1) wereldwijde eerlijke toegang tot medische producten, 2) versterking van de mondiale surveillance structuur, 3) verbeterde informatiedeling van virusmateriaal, gekoppeld aan benefit sharing, 4) de One Health-benadering en 5) afspraken over de naleving van al bestaande en nieuwe verplichtingen. Nederland erkent het belang van een pandemieverdrag, en zal zelf deelnemen aan het bureau dat de onderhandelingen coördineert.
